### **1. NON-REFUNDABLE POLICY**

All payments made toward this trip are **strictly non-refundable** under any circumstances.

This includes, but is not limited to:

- Cancellation by Guest
- Missed payments
- Schedule conflicts
- Personal emergencies
- Failure to attend trip

Once payment is submitted, no refunds, credits, or transfers will be issued for any reason.

### **2. PAYMENT SCHEDULE & LATE PAYMENT POLICY**

Guests are responsible for making all payments **on or before assigned due dates**.

#### **Late Payment Policy:**

- Each Guest is allowed **ONE (1) late payment**.
- Any additional late payments will result in the Guest's reservation being **forfeited and replaced** with another participant.

- **No refunds will be issued** if Guest forfeits their reservation due to missed or repeated late payments.

Payment deadlines are strictly enforced to maintain reservations and group bookings.

### 3. ACTIVITIES & EXCURSIONS POLICY

All scheduled activities and excursions listed on the itinerary are **included in the total trip cost**.

Guests understand and agree:

- Payments include all scheduled activities and excursions listed on the itinerary.
- Payments **will not be reduced, refunded, or adjusted** if a Guest chooses not to participate in an activity or excursion.
- The itinerary and payment schedule **will not be modified** to accommodate individual activity preferences.
- Guests may choose to sit out of any activity once the group arrives at the destination.
- The total trip cost remains the same regardless of participation.

If a Guest chooses to participate in additional activities not included in the itinerary:

- The Guest is responsible for arranging their own transportation.
- The Guest is responsible for covering all additional costs.
- The group schedule will not be altered.

### 4. TRANSPORTATION, TIMING & GROUP TRAVEL REQUIREMENTS

All transportation, activities/excursions, and restaurant reservations throughout the trip are pre-paid and scheduled for specific times. Because these services are reserved and operate on strict timelines, punctuality is required by all Guests.

Guests agree to:

- Arrive **on time** for all scheduled departures and meeting times.
- Follow all group transportation and activity schedules.
- Travel with the group to all scheduled locations.
- Remain ready at all scheduled locations.

Time is extremely important due to scheduled reservations for activities/excursions, restaurant reservations, and transportation services that cannot be delayed or rescheduled.

If a Guest is **late or fails to arrive on time** for any scheduled transportation, activity/excursion, or restaurant reservation:

- The group **will not wait or delay**.
- The Guest may be **left behind**.
- The Guest will be responsible for arranging their **own transportation**.

- Any missed reservations or activities/excursions **will not be rescheduled or refunded.**

Transportation and reservation schedules **will not** be adjusted for individual delays. Guests choosing to make independent plans outside the group itinerary are responsible for any additional cost and must rejoin the group at their own expense.

## **5. FOOD & SPENDING LIMIT POLICY**

Certain meals may be included in the trip.

Each guest will receive a **pre-determined spending limit** for covered meals.

Guests agree:

- Any food or meal purchases exceeding the assigned limit must be paid for by the Guest.
- The Organizer is not responsible for covering overages.
- Spending limits will be communicated prior to scheduled meals.

## **6. BEHAVIOR & CONDUCT POLICY**

This trip is intended to be a **respectful, drama-free experience** for all participants.

Guests are expected to:

- Treat all other guests, staff, and vendors with respect.
- Maintain positive and cooperative behavior.
- Follow all group expectations.
- Avoid disruptive or inappropriate conduct.

Any Guest who violates conduct expectations by causing disturbances, creating conflict, or displaying disrespectful behavior, understands their behavior may result in being **permanently** restricted from future trips organized by Journey with Nerissa.

## **7. LIABILITY ACKNOWLEDGMENT**

Journey with Nerissa is not responsible for:

- Missed transportation due to Guest tardiness.
- Personal expenses resulting from missed activities.
- Additional transportation arranged independently
- Purchases exceeding spending limits.
- Loss, theft, or damage to personal belongings.

Guests assume responsibility for their personal decisions outside scheduled group activities.

## **8. AGREEMENT TO TERMS**

By signing this Agreement, Guests confirm that:

- They have read and understand this Agreement.
- They understand all payments are non-refundable.

- They agree to all policies outlined.
- They understand that payments include all scheduled transportation, activities/excursions, and reservations.
- They accept responsibility for punctuality and conduct.

**9. ITINERARY AGREEMENT (FINAL ACCEPTANCE)**

By signing this Agreement, the Guest acknowledges that they have reviewed and accepted the official trip itinerary.

Guests understand:

- All activities and transportation are scheduled in advance.
- No adjustments will be made to accommodate individual preferences.
- Any additional activities outside the itinerary are the Guest responsibilities.
- Choosing not to participate in activities does not change transportation requirements or trip costs.
